This Application End User License Agreement ("Terms of Use") is a binding agreement between you ("you") and Ag Processing Inc a cooperative ("AGP"). These Terms of Use govern your use of the FastLane platform ("Application"). The Application is licensed, not sold, to you.

By downloading and using the Application, you acknowledge that (a) you have read and understand these Terms of Use; (b) represent that you are of legal age to enter into a binding agreement; and (c) accept these Terms of Use and agree that you are legally bound by these Terms of Use. If you do not agree to these Terms of Use, do not download and use the Application and delete it from your device. All information provided in connection with use of the Application or otherwise collected by AGP through or in connection with the Application is subject to the Privacy Policy [**INSERT LINK TO PRIVACY POLICY**] incorporated by reference into these Terms of Use. By downloading, installing, using, and providing information to or through the Application, you consent to all actions taken by AGP with respect to your information in compliance with the Privacy Policy.

### Terms and Conditions

1. License Grant. Subject to the terms of these Terms of Use, AGP grants you a limited, non-exclusive and nontransferable license to download, install and use the Application on a single device owned or otherwise controlled by you for internal business purposes and commercial activities between you and AGP. You shall not (a) copy the Application; (b) modify, translate, adapt, or otherwise create derivative works or improvements, whether or not patentable, of the Application; (c) reverse engineer, disassemble, decompile, decode, or otherwise attempt to derive or gain access to the source code of the Application or any part thereof; (d) remove, delete, alter, or obscure any trademarks or any copyright, trademark, patent, or other intellectual property or proprietary rights notices from the Application, including any copy thereof; or (e) rent, lease, lend, sell, sublicense, assign, distribute, publish, transfer, or otherwise make available the Application, or any features or functionality of the Application, to any third party for any reason, including by making the Application available on a network where it is capable of being accessed by more than one device at any time.

2. Owner of Account. Users must create individualized accounts to access the Application for receipt of information and transactional activities ("Account"). Only one main authorized contact per Account is permitted ("Owner"). The Owner of the Account will be the individual who initially creates the Account unless such individual provides to AGP a written request to transfer the Account to another individual. Owner agrees to assume and bear full responsibility for all risks and damages arising out of the use of the Application by you and any other party accessing the Application through your Account.

3. Content Ownership. The content or other materials on the Application including, but not limited to, all text, audio, images, data, software, code and other materials or elements (collectively, "Content") are owned and copyrighted by AGP, its licensors or others with all rights reserved. You may not use the Content, except as provided in these Terms of Use, without the prior written permission of AGP. All trademarks, trade names and logos and all related product names, design marks and slogans which appear on the Application are either the trademarks or service marks (registered or unregistered) of AGP or its licensors unless otherwise stated herein. AGP and its licensors expressly reserve all intellectual property rights in all Content on the Application. No license is granted to you in connection with such Content or

any other AGP intellectual property contained on the Application other than as expressly provided in these Terms of Use.

4. User Conduct. You agree to not to engage in any of the following activities on the Application: (a) upload, post or transmit any informational content that is unlawful, threatening to another person or entity, infringing, defamatory, false, misleading, abusive, harassing, libelous, vulgar, obscene, pornographic, profane, invades the privacy of another, or is otherwise objectionable; (b) impersonate another user, person or entity, including any official or employee of AGP; or (c) use the Application to advertise or perform any commercial solicitation.

You waive any and all objections to the exercise of jurisdiction over you by such courts and to venue in such courts. These Terms of Use and the Privacy Policy constitute the entire agreement between you and AGP with respect to the Application and supersede all prior or contemporaneous understandings and agreements, whether written or oral, with respect to the Application. No failure to exercise, and no delay in exercising, on the part of either party, any right or any power hereunder shall operate as a waiver thereof, nor shall any single or partial exercise of any right or power hereunder preclude further exercise of that or any other right hereunder. In the event of a conflict between these Terms of Use and any applicable purchase or other terms, the terms of these Terms of Use shall govern. AGP may modify and update these Terms of Use from time to time and will publish any such modification or update to the Application.
