**FOREIGN MATERIAL:** All foreign material over 1% expressed to nearest tenth of a percent will be deducted from gross weight. In addition to the normal foreign material deduction, corn and other grains in excess of 3% will be discounted 1% of the contract price for each 1% of fraction thereof.

**HEAT DAMAGE:** Heat damage will be discounted as heat damage and also as total damage.

**GREEN BEAN DAMAGE:** Subject to special discounts or refusal.

**OTHER COLORS:** Brown, black, etc., 1¢ per bushel for each 1% or fraction thereof in excess of 1%.

**TREATED SOYBEANS:** Not accepted. Punitive charges for contamination of soybean inventory.

**OTHER DISCOUNTS:** 10¢ per bushel for sour and/or musty, heating, COFO notations, sticks, stones, dirt or distinctly low quality beans. SAMPLE GRADE SOYBEANS WILL BE SUBJECT TO REJECTION OR ADDITIONAL DISCOUNT AT OUR DISCRETION. PURPLE MOTTLED OR STAINED SOYBEANS MAY BE SUBJECT TO DISCOUNT OR REJECTION. MATERIALLY WEATHERED SOYBEANS WILL BE INCLUDED IN TOTAL DAMAGE.

#### U.S. Sample Grade

U.S. Sample Grade shall be soybeans which:

- Do not meet the requirements for U.S. Nos. 1, 2, 3, or 4; or
- Contain 4 or more stones which have an aggregate weight in excess of 0.1 percent of the sample weight, 1 or more pieces of broken glass, 3 or more *Crotalaria* seeds (*Crotalaria spp.*), 2 or more castor beans (*Ricinus communis*), 4 or more pieces of an unknown foreign substance(s) or a commonly recognized harmful or toxic foreign substance(s), 10 or more pieces of rodent pellets, bird droppings, or an equivalent quantity of other animal filth per 1,000 grams of soybeans; or any combination of the aforementioned totaling 11 or more.
- Have a musty, sour or commercially objectionable foreign odor (except garlic odor); or
- Are heating or otherwise of distinctly low quality
